We also recognise the important and often challenging role carers play in the wellbeing of the people they care for, which is why we support carers, enabling them to benefit from our services while accompanying and supporting the person they care for.

Complementary Therapies:

Therapy services undertaken by our team of qualified Therapists are: Sports Massage, Body Massage, Indian Head Massage, Reflexology and Reiki.

Exercise:

Exercise services undertaken by our team of qualified Personal Trainers and Fitness Instructors are: One to One Personal Training sessions, Gym sessions, which include the use of: Oswestry standing frame, VibroGym, Sara Plus stand up hoist, Toning chairs and bed, various Seated and Mat based Exercise Classes and cardio and cycling hub.

We conduct a detailed assessment to identify any contra indications to the above activities, and a medical consultation prior to any activity undertaken, however we do require a signed GP's referral form or equally a referral from a MS Neurologist before we can proceed.

- Heart disease
- Thrombosis DVT
- Epilepsy
- Acute hernia, discopathy, spondylosis
- Serious cardiovascular disease
- Cancer
- Pregnancy
- Recent wounds or fractures (last 12 months)
- Severe infection
- Unstable fracture
- Cardiovascular hypertension
- Heart pacemaker (due to powerful magnets in AlterG)
- Insulin pump (due to powerful magnets in AlterG)

Precautions:

- Spinal or orthopaedic conditions
- High or low BP
- Arthritis
- Neuralgia
- Stroke
- Severe skin condition
- Severe allergy
- Slipped or prolapsed disc
- Cardiovascular disease or respiratory compromise
- Angina
- Acute or chronic back problems
